# 2017-18 Football Officials Exam For Postseason Tournament Consideration

- 1. R1 is running downfield with the ball on a punt return when teammate R2 executes a blindside block against K1 who is pursuing the runner. This blindside block is made with forcible contact and the first contact was made by R2 with his shoulder pad into K1's side (not in the back). The covering official should....
